

RESOLUTION NUMBER R- 268869

ADOPTED ON JUL 14 1987

WHEREAS, on October 2, 1986, the Planning Commission of The City of San Diego held a public hearing to consider the SINGLE ROOM OCCUPANCY (SRO) RESIDENTIAL HOTEL PROGRAM, including 27 recommendations from the SRO Work Program and the SRO Code Task Force; and

WHEREAS, the Planning Commission approved and recommends that the City Council approve:

1. The 27 recommendations with the understanding that the SRO preservation regulations apply only to the downtown area;
2. That the regulations be reviewed annually;
3. That the sunset clause not exceed five years; and
4. The further investigation of linkage fees requiring development project's contributions of monies to the low-income housing program.

BE IT RESOLVED, by the Council of The City of San Diego, that the SINGLE ROOM OCCUPANCY (SRO) RESIDENTIAL HOTEL PROGRAM is hereby approved, to include SRO Work Program Recommendations 3 through 27 in Planning Report No. 87-331.

BE IT FURTHER RESOLVED, that SRO Work Program Items 1 and 2 are referred to the Housing Commission and Public Services and Safety Committee for consideration following which those items are to be returned to this Council for its consideration.
