## RESOLUTION NUMBER R- 268871 ADOPTED ON JUL 14 1987

WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings on October 30, 1986, January 15, 1987 and March 12, 1987, to consider the proposed PENINSULA COMMUNITY PLAN AND LOCAL COASTAL PROGRAM LAND USE PLAN, of the General Plan Map in order to retain consistency between said plans; and

WHEREAS, the Planning Commission approved and recommended adoption by the City Council of said plan and that the 1968 PENINSULA COMMUNITY PLAN and the 1981 PENINSULA LOCAL COASTAL PROGRAM LAND USE PLAN be rescinded; and

WHEREAS, Council Policy 600-7 requires that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO be scheduled concurrently with all public hearings on proposed community plan amendments; and

WHEREAS, Government Code Section 65361 provides that mandatory elements of the GENERAL PLAN may not be amended more than four times per year; and

WHEREAS, it is the intention of the City Council to consider amendments of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semiannual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearings conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider said amendment and, by a majority vote, approved said plan and rescinded the 1968 PENINSULA COMMUNITY PLAN and 1981 PENINSULA LOCAL COASTAL PROGRAM LAND USE PLAN; NOW, THEREFORE.

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That this Council hereby approves the PENINSULA COMMUNITY PLAN AND LOCAL COASTAL PROGRAM LAND USE PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR-268871, and rescinds the 1968 PENINSULA COMMUNITY PLAN and 1981 PENINSULA LOCAL COASTAL PROGRAM LAND USE PLAN, and amends the MIDWAY COMMUNITY PLAN to adjust the boundary between the Midway and Peninsula communities to incorporate the area on both sides of West Point Loma Boulevard, south of Sports Arena Drive, into the PENINSULA COMMUNITY PLAN AND LOCAL COASTAL PROGRAM LAND USE PLAN.
- 2. That the PENINSULA COMMUNITY PLAN AND LOCAL COASTAL PROGRAM LAND USE PLAN, shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plan at the next scheduled omnibus hearing.
