BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF SAN YSIDRO BOULEVARD - PHASE I, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on JUL 20 1987, and bearing official Document No. W0133098, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SAN YSIDRO BOULEVARD - PHASE I.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,472,800 from CIP No. 52-166.1 SAN YSIDRO BOULEVARD - SMYTHE AVENUE TO BORDER VILLAGE ROAD (\$695,560 from CDBG Fund 18521, Dept. 5833, Org. 3307, \$500,000 from CDBG Fund 18522, Dept. 5863, Org. 6311 and \$277,240 from CDBG Fund 18523, Dept. 5633, Org. 3304) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, for further phases, in the appropriate reserves.
