APPROVING MAP OF VILLA LA PLAYA.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Andrew E. Lambert, Licensed Land Surveyor, entitled "VILLA LA PLAYA being a subdivision of a portion of Lot 25 of Aloha Tract, in the City of San Diego, County of San Diego, State of California, according to the map thereof No. 611, filed in the office of the County Recorder of San Diego County, together with a portion of Coronado Avenue as dedicated to public use, and a portion of the unnamed street as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Coronado Avenue and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby rejects as a dedication those portions of Lots 6 and 7, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.


That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across all those portions of Lots 1 through 8, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a street is accepted on behalf of the public as heretofore stated; that said Council has rejected portions of Lots 6 and 7 marked "Reserved for Future Street"; and the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
