BE IT RESOLVED, by the Council of The City of San Diego, as follows:



That the City Manager is hereby authorized to initiate proceedings for the formation of said Landscape Maintenance District pursuant to the Landscape and Lighting Act of 1972 (Streets and Highways Code, Sections 22.500, et seq.) and the San Diego Maintenance District Procedural Ordinance of 1975 (San Diego Municipal Code, Sections 65.0201, et seq.), said district shall be known and designated as the Logan Avenue Landscape Maintenance District.

3. That the above described district will be for maintenance purposes only and the district proposes no construction of facilities at this time.
