GRANT, executed in favor of The City of San Diego, bearing date of May 7, 1987, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-268911-1 and RR-268911-2, granting to said City easements for a public street and drainage purposes in a portion of Parcel 1 of Parcel Map 11933, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named STADIUM WAY.



adopted June 2, 1987.
