WHEREAS, in response to a Request for Proposals for Sacramento Representational Services for The City of San Diego, the Intergovernmental Relations Department received fifteen proposals; and

WHEREAS, the Committee on Rules, Legislation and Intergovernmental Relations requested that the Mayor bring forth a recommendation; and

WHEREAS, five firms were selected and interviewed on the basis of submitted proposals; and

WHEREAS, the firm of Rees and Associates, Incorporated was one of the five firms interviewed; and


