Vincent DeLeva	General Services	\$2,348.40	Mr. DeLeva is an Electrical Supervisor with the Communications and Electrical Division. He suggested converting the existing lighting in the City College "B" Street tunnel to low sodium lighting. This is expected to save \$15,656 electricity.
Richard Diederich	General Services	\$ 500.00	Mr. Diederich is a Equipment Mechanic with the Equipment Division. He suggested replacing the current air cleaner system with the Donaldson Air Cleaner. Although savings are difficult to identify, this was considered to be a significant operational improvement.
