James Brooks	Fire	\$320.00	Mr. Brooks is a Fire Engineer. He suggested consolidating information in the New Hydraulics Manual into two sheets to be placed in the Engineers Manual. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Rodney Ballard	Fire	\$320.00	Mr. Ballard is a Firefighter. He suggested replacing soft foam cervical collars by extrication type collars. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Norman Jones	General Services	\$160.00	Mr. Jones is a Plumber with the Buildings Division. He suggested installing caps on roof vents of plumbing systems. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Arlen Turman	Police	\$160.00	Mr. Turman is a Sergeant. He suggested having Police Officers use the Trolley instead of the court van. Although savings are difficult to identify, this was considered to be a significant operational improvement.
