Gifford Blakesley	Police	\$90.00	Mr. Blakesley is Police Officer II. He suggested using plastic in a Hexagon shape for School Stop signs. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Marilyn Baldwin	Risk Management	\$90.00	Ms. Baldwin was an Intermediate Typist with the Safety Division at the time of this suggestion. She suggested providing "Buckle Up" windshield stickers for Employee's cars. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Stephen Linges	Fire	\$90.00	Mr. Linges is a Captain. He suggested using a rolling odometer to compute square footage during occupancy inspections. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Bradley Cronk	Risk Management	\$45.00	Mr. Cronk is a Captain with the Fire Department. He suggested printing RM-1568 (Report of Minor Injury) in triplicate to provide employee with a copy. Although savings are difficult to identify, this was considered to be a significant operational improvement.
