APPROVING MAP OF FASHION RIDGE.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Peter C. Golding, Licensed Land Surveyor, entitled "FASHION RIDGE being a subdivision of a portion of Lot 1 of Mission Valley Ball Park according to Map No. 3755, portions of Pueblo Lot 1174 of the Pueblo Lands of San Diego per map by James Pascoe in 1870, all in the City of San Diego, County of San Diego, State of California, together with a portion of Friars Road as dedicated to public use and a portion of Friars Road as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Friars Road and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, that said portion of a street is accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
