APPROVING PARCEL MAP NO. TM-86-0814.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Earl E. Penny, Registered Civil Engineer, entitled "PARCEL MAP NO. TM-86-0814 being a division of: Lots 1, 2, 3, 4 and 5, Block 10 of Cable Road Addition, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 669, filed in the office of the County Recorder of said County May 23, 1891 together with portions of Liggett Street and the unnamed alley in Block 10, as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Britt Court and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a street is accepted on

behalf of the public as heretofore stated; all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Liggett Street and the alley adjoining Lots 1 through 5, Block 10, of Map No. 669, approved by Council Resolution No. R-267634, on February 9, 1987, concurrently with the filing of the map.
