- That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 268931 granting to SWA DEVELOPMENT, a general partnership or nominee, all that portion of Block 30 of Sorrento Lands and Townsite, Map No. 483, as more particularly described in said grant deed.
- That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.
- That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
