
ADOPTED ON JUL 27 1987

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue two checks in the amounts of \$302,764.00, made payable to Transamerica Annuity Service Corp., and \$1,197,236.00, made payable to Alan Wayne Hanson and his attorney, Terry Singleton, in full settlement of the lawsuit and of all claims.
