
ADOPTED ON JUL 27 1987

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Lloyd Koenig, Architect, for the improvement of Mira Mesa Community Park - Picnic Shelter and Standley Community Park - Picnic Shelter, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 268943.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$16,500 (\$8,500 from CIP No. 29-597.0, Mira Mesa Community Park - Picnic Shelter, and \$8,000 from CIP No. 29-602.0, Standley Community Park - Picnic Shelter, Park Service District Funds), is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
