RESOLUTION NUMBER R- 268945  
ADOPTED ON JUL 27 1987

WHEREAS, on March 10, 1987, the City Council by Resolution No. R-267854 authorized the City Manager to administratively abate by demolition the premises located at 3237-43 Commercial Street, San Diego, California, more particularly described as:

Lots 9, 10, 11, 12 and 13 in Block 135 of Central Park in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 435, filed in the office of the County Recorder of said San Diego County, November 9, 1887;

and

WHEREAS, the City Manager incurred total administrative and actual expenses of \$5940.00 to hire a contractor to complete the demolition at 3237-43 Commercial Street and remove all associated debris; and


WHEREAS, a record of the costs of all demolition and administrative work has been reviewed by the City Council; and

WHEREAS, the City Council pursuant to San Diego Municipal Code section 11.16 has reviewed the record of the costs transmitted by the City Manager and has provided the opportunity for anyone interested in the above-described property to contest the total abatement costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby confirms the cost of abatement of the property at 3237-43 Commercial Street at \$5940.00 and a special assessment in the amount of \$5940.00 be levied against the above-described property.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to collect this special assessment and provide proper documentation to the County Auditor before August 10, 1987, to incorporate this assessment on the municipal tax bill for this property to be collected in the same manner as ordinary municipal taxes, pursuant to Government Code sections 38773 and 38773.5.
