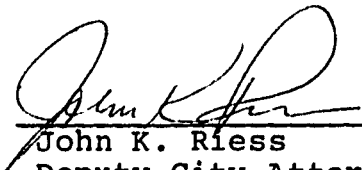
RESOLUTION NUMBER R- 268950

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$18,976 from CIP No.53-035, Ingraham Street Bridge Over Mission Bay Channel, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
