RESOLUTION NUMBER R- 268954

ADOPTED ON JUL 27 1987

WHEREAS, staff from the offices of the City Manager, City Attorney and Planning Director conducted numerous meetings evaluating the feasibility of: (1) a biannual regulated housing inspection program; (2) a citywide code enforcement sweep; and (3) recovering implementation and operation costs of both proposed programs.

WHEREAS, staff prepared a City Manager's Report (#87-378) which preliminarily analyzed the issues and estimated costs and revenues for: (1) a biannual regulated housing inspection program; (2) a citywide code enforcement program; and (3) alternatives to recover implementation and operation costs of both proposed code enforcement programs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that staff recommendations listed in City Manager's Report #87-378 are hereby adopted;

BE IT FURTHER RESOLVED, that the City Manager is directed by the Council to immediately proceed with the biannual regulated housing inspection program and return to Council with all appropriate amendments to the Municipal Code and necessary administrative procedures; and

BE IT FURTHER RESOLVED, that the Planning Director is directed to immediately proceed with establishing a biannual inspection and enforcement program in the areas of sign code,

landscaping and discretionary permits (i.e. CUP) and return to Council with all appropriate amendments to the Municipal Code and necessary administrative procedures.
