

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an amendment to the Scope of Services section of the joint participation agreement with SANDAG, under the terms and conditions set forth in that amendment on file in the office of the City Clerk as Document No. RR- 268955.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$15,000 from the Planning Department budget (General (100) Fund) is hereby authorized solely and exclusively for the above-described consultant services.
