BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager's recommendations regarding uses for those buildings being retained on the Balboa Naval Hospital site - Administration Building (Bldg. 1) and the Library/Auditorium (Bldg 8) - are hereby approved and the City Manager is hereby directed to take all actions necessary to implement those recommendations, as follows:

a) Administration Building - Return to Council with a consultant services agreement to convert the building to office uses for the Park and Recreation Department, as defined in City Manager Report No. 87-263; and

b) Library/Auditorium - Issue a Request for Proposals (RFP) soliciting proposals from groups interested in leasing the building for museum use or for other allowable park purposes.
