

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TEMPORARY REINFORCEMENT REPAIRS FOR SOLEDAD RESERVOIR in accordance with the specifications.
