BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the City Manager be and he is hereby authorized to accept \$36,000 grant from the U.S. Department of Housing and Urban Development (HUD) for the provision of emergency shelter services in the City of San Diego.

2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Episcopal Community Services, Inc., to operate an emergency shelter facility that will provide temporary lodging for the homeless individuals in the San Diego area, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- **269004** .

3. That the expenditure of an amount not to exceed \$36,000, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the

administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
