

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$43,500 from CIP No. 29-563.0, Coast Boulevard Park - Improvements, Capital Outlay Fund 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and further authorizing the City

Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
