BE IT RESOLVED, by the Council of The City of San Diego, that  
all said proposals or bids are hereby rejected except that herein  
mentioned and hereby awards the contract for doing said work and  
improvement to the lowest regular responsible bidder, to wit:  
Mur-Vic Construction Company, Inc., a corporation, at the prices  
named in the bid of said bidder on file in the office of the City  
Clerk.

BE IT FURTHER RESOLVED, that the City Clerk is hereby  
directed to cause notice of this award to be published twice in  
the City Official Newspaper and to record notice of this award in

the office of the County Recorder as provided in Section 5248 of  
the Streets and Highways Code.
