WHEREAS, Scott won the NCAA Championship two years consecutively and was chosen Golfer of the Year by the NCAA; and

WHEREAS, Scott Simpson qualified three times in the tour qualifying school, thus being certified for play by the PGA in an unusually short time frame; and

WHEREAS, Scott won the Western Open in Chicago six years ago, only three years after being on tour; and

WHEREAS, Scott Simpson won the 1987 United States Open Tournament at San Francisco's Olympic Club; and

WHEREAS, the U.S. Open is the most important golf tournament in the world; and

WHEREAS, this feat earned Scott Simpson a place on the Ryder Cup Team, an accomplishment achieved by very few pro players; and

WHEREAS, Scott Simpson's achievement assured him of the opportunity to play in the prestigious British Open; and


