WHEREAS, The City of San Diego finds that the construction of the proposed Bayside Light Rail Trolley Line will have a positive impact on The City of San Diego and the Convention Center; and

WHEREAS, The City of San Diego, the Redevelopment Agency of The City of San Diego, the Centre City Development Corporation, Inc., the San Diego Metropolitan Transit Development Board, and the San Diego and Arizona Eastern Railroad have agreed on a Cooperation Agreement relative to acquisition, relocation, and conveyance of certain properties for purposes of the construction of the Bayside Light Rail Trolley Line and the development of an attendant strip park, related redevelopment, and the expansion and realignment of Harbor Drive; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager, or his designee, is hereby authorized, on behalf of the City, to execute the Cooperation Agreement with the Redevelopment Agency of The City of San Diego, the Centre City Development Corporation, Inc., the Metropolitan Transit Development Board, and the San Diego and Arizona Eastern Railroad for the Bayside Light Rail Trolley Line and Extension to Old Town, a copy of which is on file in the office of the City Clerk as Document No. RR- 269021.
