A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A SPECIAL MUNICIPAL BOND ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON NOVEMBER 3, 1987 WITH THE GENERAL MUNICIPAL ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, this Council has commenced proceedings and intends to call a Special Municipal Bond Election in the City to be held on November 3, 1987 for the purpose of submitting to the qualified voters of the City general obligation bond propositions as set forth in this resolution; and

WHEREAS, it is desirable that this Special Municipal Bond Election be consolidated with the General Municipal Election to be held on the same date and that within the City, the election precincts, polling places, voting booths and election officials for the two elections be the same, and that the Registrar of Voters of the County of San Diego be authorized to canvass the returns of the Special Municipal Bond Election, and that this Special Municipal Bond Election and the General Municipal Election be held in all respects as if there were only one election; and

WHEREAS, this Council within the time required by law has or will adopt an ordinance calling for a Special Municipal Bond Election and consolidating it with the General Municipal Election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Board of Supervisors of the County of San Diego is hereby requested to consolidate a Special Municipal Bond Election to be held in the City of San Diego on November 3, 1987 with the General Municipal Election to be held on the same date.

2. The exact form of the propositions to be voted upon at the Special Municipal Bond Election as such propositions shall appear on the ballot are as follows:

BALBOA PARK AND MISSION BAY PARK PRESERVATION AND IMPROVEMENT BONDS</u></p> <p>Shall The City of San Diego incur bonded indebtedness in the principal amount of \$93,520,000 with \$73,860,000 spent for the purpose of park and recreation municipal improvements, including but not necessarily limited to, improvement of water quality in Mission Bay Park; construction of facilities to protect against sewage spills in Mission Bay Park; for reconstruction, structural and safety improvements to buildings and museums in Balboa Park constructed prior to 1935; improvement of beach areas and the shoreline in Mission Bay Park to prevent erosion and the loss of beach area; improved access for senior citizens and handicapped visitors in Balboa Park; and with an additional amount of \$19,660,000 spent for the additional purpose of, but not limited to, construction of pedestrian paths and other improvements to Fiesta Island, completion of Crown Point Shores, all in Mission Bay Park, construction of parking and vehicle circulation improvements in Balboa Park and Mission Bay Park, construction of a new municipal gym outside Balboa Park, improvements to the Space Theater and Starlight Bowl, all in Balboa Park, and for payment of all costs and expenses in connection with such acquisition and construction and the issuance of the bonds?</p>	<p>Y E S</p>

The propositions shall be designated on the ballot by a letter printed on the left margin of the square containing the description of the measure as provided in Section 10219 of the Elections Code of the State of California.

3. The Registrar of Voters of the County of San Diego is hereby authorized to canvass the returns of this Special Municipal Bond Election and is requested to conduct the elections in all respects as if there were only one election using only one form of ballot.

4. That the Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the General Municipal Election appropriate instructions to take any and all steps necessary for the holding of a consolidated election.

5. That the City Clerk of The City of San Diego is hereby directed to file a certified copy of this resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.

6. That the County of San Diego shall be reimbursed in full for the services performed by the Registrar of Voters for The City of San Diego in connection with the election services herein described.

7. That The City of San Diego agrees to indemnify and to save free and harmless the County, its officers, agents and employees from expense or liability, including reasonable attorneys' fees, as the result of an election contest initiated pursuant to the provisions of Division 13 of the Elections Code of the State of California after conduct of these elections.
