WHEREAS, the Association will celebrate its 35th Anniversary of successfully representing the Downtown business community on August 5, 1987; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, does hereby proclaim August 5, 1987 as "CENTRAL CITY ASSOCIATION DAY" and commends the officers and members on their unselfish achievements for the benefit of the total community.
