
RESOLUTION NUMBER R- 269029

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with NBS/LOWRY CONSULTANTS, INC., for engineering services for the design of Sewer Main Replacement Groups 85 and 86, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269029.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$328,167 for Sewer Main Replacement Groups 85 and 86 (\$180,223 for Group 85 and \$147,944 for Group 86) from the Sewer Revenue Fund (41506), annual allocation for sewer main replacements (CIP No. 44-001), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
