
RESOLUTION NUMBER R- 269037

BE IT RESOLVED, by the Council of The City of San Diego that the low bid of JONES CHEMICALS, INCORPORATED, meeting specifications is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SODIUM HYPOCHLORITE 12.5% IN SOLUTION as may be required for a period of one (1) year beginning October 1, 1987 through September 30, 1988, at a cost of \$0.467 per gallon, for a total estimated cost of \$46,700.00; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period with a price escalation not to exceed 10% of bid price.

BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized to purchase sodium hypochlorite on an emergency basis in the event the contractor fails to deliver this material on any occasion, from Imperial West Chemical, GPS Industries, Hasa Inc., Hill Bros. Chemical or Abcana Chemical, per prices on file in the Purchasing Department, or on the open market in the event emergency vendors are unable to deliver.
