- 2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
- 3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the SAN DIEGO JACK MURPHY STADIUM SOUND SYSTEM IMPROVEMENTS.
- 4. That the addition of CIP 34-106, SAN DIEGO JACK MURPHY STADIUM SOUND SYSTEM IMPROVEMENTS to the FY 1988 Capital Improvement Program is hereby authorized.
- 5. That the City Auditor and Comptroller is hereby authorized to transfer \$379,436.09 (\$359,325.57 in revenues and \$20,110.52 in expenditures savings authorized by Ord. #16778) and

all future interest earnings from Fund 10333 and transfer up to \$73,563.91 from CIP 37-420.0, Funds 30245 and 10332, San Diego Jack Murphy Stadium Electrical Transformer Replacement to CIP 34-106, SAN DIEGO JACK MURPHY STADIUM SOUND SYSTEM IMPROVEMENTS.

6. That the expenditure, not to exceed \$453,000 from Funds 30245 and 10333, CIP 34-106, SAN DIEGO JACK MURPHY STADIUM SOUND SYSTEM IMPROVEMENTS is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
