ADOPTED ON AUG 10 1987

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE IMPROVEMENT OF MIRAMAR ROAD BRIDGE OVER THE ATCHISON, TOPEKA AND SANTA FE RAILROAD, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on AUG 10 1987, and bearing official Document No. U.D. 118700, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE IMPROVEMENT OF MIRAMAR ROAD BRIDGE OVER THE ATCHISON, TOPEKA AND SANTA FE RAILROAD.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$150,000 from the FBA Fund No. 79006, Revenue Account No. 73460 to CIP No. 53-042 MIRAMAR ROAD BRIDGE OVER THE SANTA FE RAILROAD.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$780,000 from CIP No. 53-042 MIRAMAR ROAD BRIDGE OVER THE SANTA FE RAILROAD is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
