

WHEREAS, the studies only show a partial picture of lending activity in the County to provide a complete picture of its influence and land use redevelopment and the quality of life;

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby expresses its support for SB 1556 (Petris) as amended July 8, 1987, which will require all persons in the business of originating residential mortgage and small business in the state not covered by the Home Mortgage Disclosure Act to report their activity.
