RESOLUTION NUMBER R- **269050**

ADOPTED ON AUG 10 1987

WHEREAS, in order to change rates for usage of the City's sewer and water systems, public notice for a public hearing must be published in a newspaper in the district or, if none is available, a newspaper of general distribution, at least ten days prior to that hearing; and

WHEREAS, SB 1397 (Kopp) requires public noticing to be made by mail to every user, property owner served or proposed to be served and all ratepayers at least ten days prior to the public hearing; and

WHEREAS, the language of the proposed legislation is ambiguous and confusing; and

WHEREAS, the added costs of this noticing would create additional economic burden on City of San Diego ratepayers; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, does hereby express and declare its opposition to SB 1397 (Kopp) and directs the Intergovernmental Relations Department to work with the author to resolve the opposition by clarification of the language

of the proposed legislation and reduction of the economic burden
to the ratepayers.
