empowered to execute, for and on behalf of said City, an agreement with the Hillcrest Business Improvement Association, Inc., for the operation of the District, for the one (1) year period from July 1, 1987 through June 30, 1988, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR- $\frac{269067}{}$.
