WHEREAS, the La Jolla Parking and Business Improvement Area (the "Area") was established in 1978 for the purpose of general promotion and development of retail trade, public parking, and the promotion of alternative modes of transportation; and

WHEREAS, on July 1, 1985, the special assessment on businesses within the district ended and the Area ceased operating on December 31, 1985; and

WHEREAS, the Area Fund remains in existence until its activities are completed and funds are fully expended, and since the main source of funds was a special assessment on business licenses, the residual balance which must be expended in the La Jolla business community; and

WHEREAS, the La Jolla Town Council, Inc., has agreed to assume the responsibilities of the former Area until such time as the fund balance is expended; and

WHEREAS, the La Jolla Town Council, Inc., has met the requirements of their first year agreement; and

WHEREAS, it is now recommended that this agreement be renewed for a one (1) year period between July 1, 1987 to June 30, 1988; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an

agreement between The City of San Diego and the La Jolla Town Council, Inc., for the purpose of administering the parking and traffic issues program in the La Jolla area, for the period of July 1, 1987 through June 30, 1988, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR-269068.
