WHEREAS, the North Park Business Improvement District (the "District") was established by Ordinance No. O-16481 (New Series), adopted on July 29, 1985; and

WHEREAS, the District was established to provide more efficient use of parking facilities and improve traffic circulation, improve pedestrian and urban amenities, and to promote the community through special events, marketing and advertising; and

WHEREAS, the program is financed by a special assessment upon businesses located within the area and collected annually by the City Treasurer with the business license fees, and the assessment is based upon categories of benefit for those businesses located within the District; and

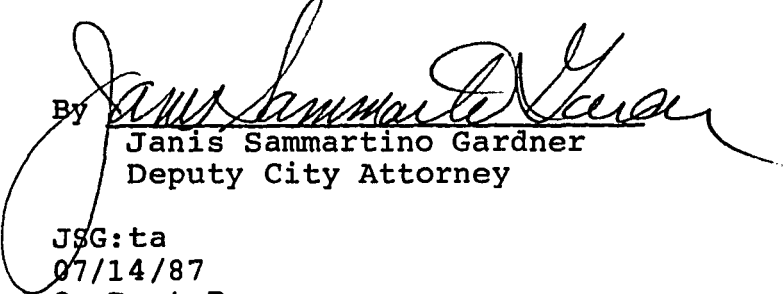
WHEREAS, The City of San Diego contracted with the North Park Business Improvement Association, Inc., when the District was established to accomplish the objectives of the District; and

WHEREAS, the North Park Business Improvement Association, Inc., has met the requirements of their second year agreement; and

WHEREAS, it is now recommended that this agreement be renewed for a one (1) year period between July 1, 1987 and June 30, 1988; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, an agreement with the North Park Business Improvement Association, Inc., for the operation of the District, for the one (1) year period from July 1, 1987 through June 30, 1988, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR- 269069 .
