That the City Auditor and Comptroller is hereby authorized to expend an amount not to exceed \$199,000 from General Fund (Resource Conservation & Management Program and General Services Department, Refuse Disposal Division), solely and exclusively for the purpose of providing funds for the execution of the above agreements and authorizing the City Auditor and Comptroller upon advice from the

administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
