BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with San Diego Ecology Centre, Inc., to provide recycling and resource recovery education, information and action programs, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269071-1.

2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with San Diego Ecology Centre, Inc., to operate a demonstration tire shredding and recycling program at Miramar Landfill for a period of six (6) months, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 269071-2.

3. That the City Auditor and Comptroller is hereby authorized to expend an amount not to exceed \$199,000 from General Fund (Resource Conservation & Management Program and General Services Department, Refuse Disposal Division), solely and exclusively for the purpose of providing funds for the execution of the above agreements and authorizing the City Auditor and Comptroller upon advice from the

administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
