
RESOLUTION NUMBER R- 269079

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$775,600 from General Fund, Nondepartmental Expense (Program 60101), is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
