BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF BOAT LAUNCHING FACILITIES AT SUTHERLAND RESERVOIR, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on AUG 10 1987, and bearing official Document No. W.O. 180219, be and the same are hereby approved.


BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF BOAT LAUNCHING FACILITIES AT SUTHERLAND RESERVOIR.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$316,375 within the Water Revenue Fund 41502 from the Unallocated Reserve 70679 to the Lakes Recreation Construction Program 70393, CIP No. 73-230 ANNUAL ALLOCATION - VARIOUS LAKES.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$316,375 from Water Revenue Fund 41502, CIP No. 73-230 ANNUAL ALLOCATION - VARIOUS LAKES is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
