

RESOLUTION NUMBER R-269094

ADOPTED ON AUGUST 10, 1987

RESOLUTION CONSIDERING THE PROTESTS, APPROVING MODIFIED MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE NORTH CITY WEST LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT.

WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of "North City West Landscape and Lighting Maintenance District," under Resolution of Intention No. R- 268510, adopted on June 8, 1987, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, except for those relating to Parcel Nos. 307-161-61, 307-180-24 and 307-180-31, are overruled.
2. Except for the assessments for Parcel Nos. 307-161-61, 307-180-24 and 307-180-31, the assessments described in Document No. RR- 268511, on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved. The assessments for Parcel Nos. 307-161-61, 307-180-24 and 307-180-31 are hereby removed from the assessment roll of this district until such time as the ownership of the properties changes.
