## RESOLUTION NUMBER R-269096 ADOPTED ON AUGUST 11, 1987

WHEREAS, there have been roughly 500 cases of AIDS in San Diego County and 300 deaths; and

WHEREAS, the San Diego County Regional Task Force on AIDS estimates that by 1991 there will have been 7,500 cases of AIDS in the County; 40,000 cases of AIDS Related Complex (ARC) and 75,000 infected individuals without symptoms; and

WHEREAS, health issues are traditionally considered to be predominately within the jurisdiction of the County; and

WHEREAS, the health crisis precipitated by AIDS has generated a great deal of legislative activity in Sacramento and Washington, D.C.; and

WHEREAS, in response to the increased legislative activity, the San Diego County Regional Task Force on AIDS has proposed a draft policy to be used by the County; and

WHEREAS, because of the scope and impact of AIDS on the citizenry of San Diego, a more active role in health, education, civil liberty and social service legislative issues concerning this topic is desired; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the legislative recommendations regarding AIDS contained in IRD Report No. 87-15, dated June 22, 1987, as approved unanimously by the Rules Committee on July 15, 1987, be and they are hereby approved.
