WHEREAS, San Diego and National City are neighbors committed to working to eradicate drugs from their respective communities through a variety of law enforcement, educational and preventative programs; and

WHEREAS, San Diego and National City are served by Paradise Valley Hospital which has pledged its support for these two cities' fight against drugs through a two-day program featuring television star Clifton Davis called, "NEIGHBORS AGAINST DRUGS;" and

WHEREAS, drug abuse is tenacious in its hold on our young people and there is a great need to focus attention on positive role models like Clifton Davis, to heighten parental awareness of those issues that lead to drug abuse, and to support law enforcement officers and educators in their efforts to help youngsters make positive choices in their lives; and


WHEREAS, this two-day event, sponsored by U.S. Congressman Jim Bates and State Senator Wadie Deddeh, includes a county-wide essay which will raise funds for five drug treatment programs; and

BE IT RESOLVED, by the Council of The City of San Diego, that August 22, 1987 be and it is hereby proclaimed to be "NEIGHBORS AGAINST DRUGS DAY" in San Diego, and that all citizens are urged to recognize and support our City's work in eradicating drugs from our community.
