
BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$231,519.38 by WM. J. KIRCHNAVY CONST. INC., a corporation, meeting specifications for THE IMPROVEMENTS OF WEST MUIRLANDS DRIVE AT FAY STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 122413.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$60,000 from CIP No. 52-301 NAUTILUS STREET - AVENIDA LA REINA TO AVENIDA DE LAS PESCAS to CIP No. 52-306 WEST MUIRLANDS DRIVE AT FAY AVENUE.

3. That the expenditure, not to exceed \$60,000 from CIP No. 52-306 WEST MUIRLANDS DRIVE AT FAY AVENUE to supplement funds previously authorized by Resolution No. 268103, adopted on April 20, 1987, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
