"COMPACTOR/VIBRATORY RAMMER" PARTS as may be required for a period of one (1) year beginning September 1, 1987 through August 31, 1988, as follows:

1. TRENCH PLATE RENTAL CO. for Section I at 10% discount from list price, plus applicable California sales tax; terms net, with an option to renew contract for two (2) additional one (1) year periods, price escalation not to exceed 50% of prices in effect at the end of prior year.
2. CLAIREMONT EQUIPMENT CO. for Section II at list prices, plus applicable California sales tax; terms 10% 20 days, with an option to renew contract for two (2) additional one (1) year periods, price escalation not to exceed 20% of prices in effect at the end of prior year.
