APPROVING MAP OF CARMEL VALLEY NEIGHBORHOOD 1
- UNIT 9.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Phillip S. Butcher, Licensed Land Surveyor, entitled "CARMEL VALLEY NEIGHBORHOOD 1 - UNIT 9 being a subdivision of portions of Parcels 1, 2 and 3, of Parcel Map No. 14460 as filed in the office of the County Recorder of San Diego County, September 12, 1986, as File/Page No. 86-402405 of official records, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Azzuro Court, Belvista Court, Prego Court, Aida Street, Carmel Knolls Drive, Carmel Canyon Road, and Tarantella Lane and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Carmel Canyon Road, adjacent and contiguous to Lots 11 through 28, inclusive, in and to Carmel Knolls Drive, adjacent and contiguous to Lots 7 through 11, inclusive, Lots 34, 35 and 36, and Lots 46 through 53, inclusive, and in and to Belvista Court, adjacent and contiguous to Lots 57 through 60, inclusive, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) listed in paragraphs 2 through 4 of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) are accepted on behalf of the public as heretofore stated; those certain abutters' rights of access, and those easements listed in paragraphs 2 through 4 of the Owner's Certificate, all as granted and shown on the map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
