
RESOLUTION NUMBER R- 269148

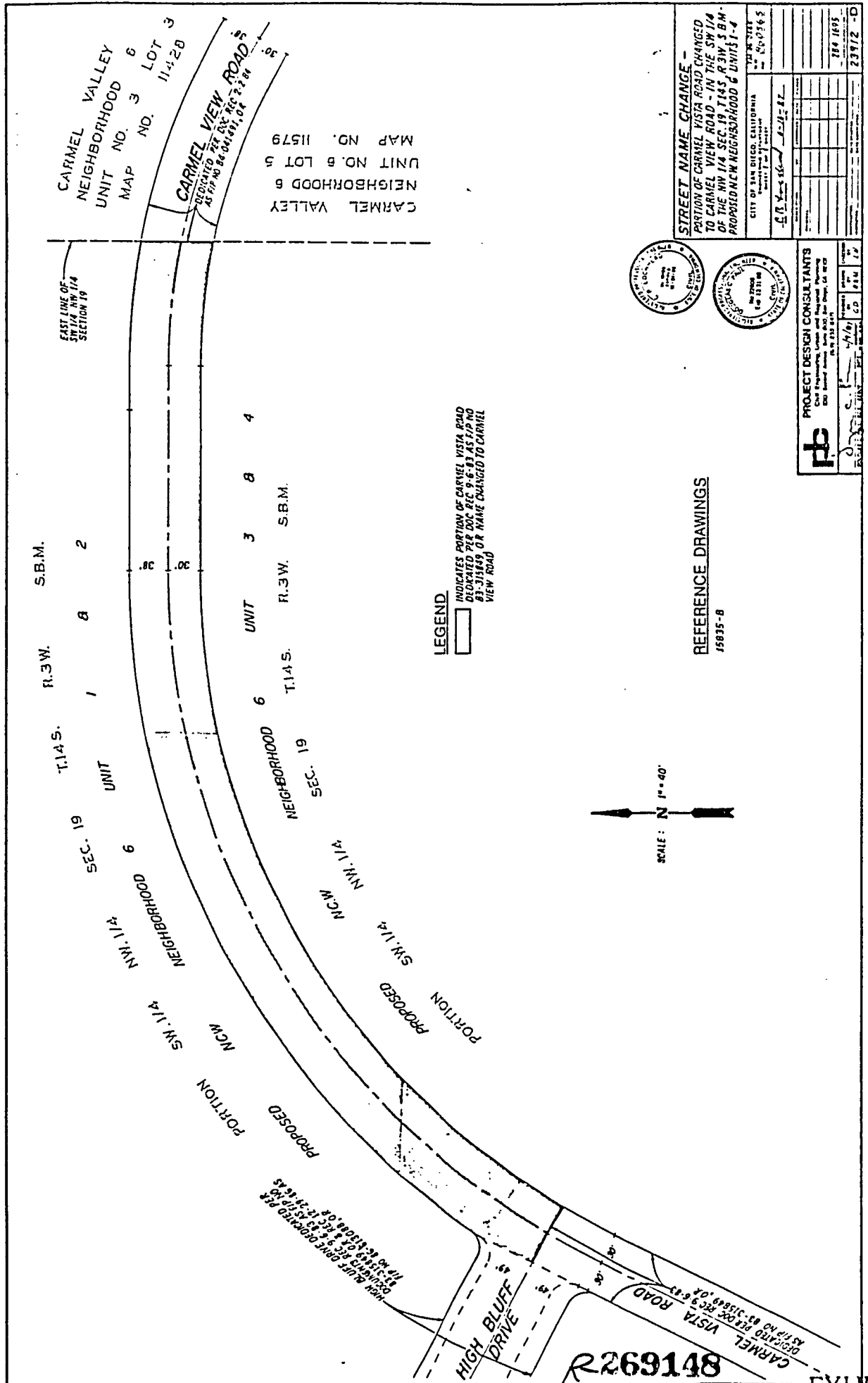
