BE IT RESOLVED, by the Council of The City of San Diego, that portions of Lot 60 of Rancho Mission of San Diego, and portions of Lots 1 through 8, inclusive, of the subdivision of Lots 61, 62 and the easterly portion of Lot 63 of Rancho Mission of San Diego, as more particularly described in the legal description attached hereto as Exhibit A and by this reference incorporated herein, be, and the same are hereby dedicated as and for a public street, and the same is hereby named TIERRASANTA BOULEVARD.

BE IT RESOLVED, that portions of Lot 53 of Rancho Mission of San Diego, and portions of Lots 1 through 8, inclusive, of the subdivision of Lots 61, 62 and the easterly portion of Lot 63 of Rancho Mission of San Diego, as more particularly described in the legal description attached hereto as Exhibit A and by this reference incorporated herein, be, and the same are hereby dedicated as and for a public street, and the same is hereby named MISSION GORGE ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

LEGAL DESCRIPTIONParcel 1 - Tierrasanta Boulevard

Those portions of Lot 60 of Rancho Mission of San Diego, according to Partition Map of said Rancho made in the action entitled "Juan M. Luco, et al, vs. The Commercial Bank of San Diego, et al," Superior Court Case No. 348 filed in the Office of the County Clerk of said County and Lots 1-8 inclusive of the subdivision of Lots 61, 62 and the easterly portion of Lot 63, Rancho Mission of San Diego, according to Map thereof No. 1550, filed in the Office of the County Recorder of said County, being a strip of land 102.00 feet wide lying 51.00 feet on each side of the following described centerline:

Beginning at a point on the northwesterly line of ROS Map No. 7328 on file in the Office of said County Recorder as File No. 225735 in book of Record of Survey Maps at page 7328, said point also being on the northeasterly prolongation of the southeasterly line of Lot 301, El Dorado Hills Unit No. 13 according to Map thereof No. 9151 filed in the Office of said County Recorder, said point lies North  $44^{\circ}00'46''$  East (record per ROS 7328, North  $44^{\circ}00'43''$  East), 214.51 feet from the southwest corner of said Lot 301, said point also being a point on the centerline of the southeasterly terminus of land dedicated as Tierrasanta Boulevard, conveyed to the City of San Diego by deed recorded April 27, 1978 as File/Page 78-16970, Book 1978, Official Records; thence leaving said northwesterly line of ROS 7328, South  $39^{\circ}18'17''$  East, 465.79 feet to the beginning of a tangent 2,493.01-foot radius curve concave southwesterly; thence southeasterly along the arc of said curve through a central angle of  $22^{\circ}56'17''$  a distance of 935.0 feet, more or less, to a terminus in the northwesterly line of that 8.0-foot-strip of land described in Parcel 2 herein.

The sidelines of the above-described strip of land shall be prolonged or shortened so as to terminate northwesterly in said northwesterly line of ROS 7328 and southeasterly in the northwesterly line of Parcel 2 herein.

Parcel 2 - Mission Gorge Road

Those portions of Lot 53 of Rancho Mission of San Diego, according to Partition Map of said Rancho made in the action entitled "Juan M. Luco, et al, vs. The Commercial Bank of San Diego, et al," Superior Court Case No. 348 filed in the Office of said County Clerk of San Diego and Lots 1-8 inclusive, 14-16 inclusive, of the subdivision of Lots 61, 62 and easterly portion of Lot 63 of Rancho Mission of San Diego, according to Map thereof No. 1550 filed in the Office of the County Recorder of said County, being a strip of land 8.00 feet wide more particularly described as follows:

The northwesterly 8.0 feet of a 63.00-foot-strip of land lying northerly and northwesterly, measured at right angles, of the following described line:

Beginning at the most northerly corner of Allied Gardens Unit No. 10, according to Map No. 3439 on file in said Office of the County Recorder, said point being a point on the south line of Lot 63 of Rancho Mission and on the center-line of Mission Gorge Road; thence North  $30^{\circ}18'06''$  East, 23.40 feet to the beginning of a tangent curve to the right having a radius of 5,000 feet; thence northeasterly along said curve through a central angle of  $3^{\circ}12'56''$  a distance of 280.61 feet; thence tangent to said curve North  $33^{\circ}31'02''$  East, 494.38 feet to the beginning of a tangent curve to the right having a radius of 1,500 feet; thence northeasterly along said curve, through a central angle of  $28^{\circ}13'45''$  a distance of 739.04 feet; thence tangent to said curve North  $61^{\circ}44'47''$  East, 3,322.42 feet to the beginning of a tangent curve to the right having a radius of 5,000 feet; thence easterly along said curve through a central angle of  $23^{\circ}54'51''$  a distance of 2,086.91 feet; thence tangent to said curve North  $85^{\circ}39'38''$  East, 484.01 feet to the beginning of a tangent curve to the left having a radius of 2,000 feet; thence easterly and northeasterly along said curve through a central angle of  $53^{\circ}29'54''$  a distance of 1,867.44 feet; thence tangent to said curve North  $32^{\circ}09'44''$  East, 609.84 feet to a point on the east line of Lot "E" of the Partition of a portion of Lot 70 of said Rancho Mission of San Diego, distant thereon North  $01^{\circ}13'25''$  East, along said east line 1,025.51 feet from the southeast corner of land described in deed to the Southern Title Guaranty Company recorded in Book 847, page 385 of Deeds, records of said San Diego County.

Excepting therefrom any portion of the above-described strip of land lying southwesterly of the lands described in Parcel 1 of deed dated March 1, 1967 and recorded March 1, 1967 as Document No. 27952, filed in the Office of said County Recorder. Also excepting therefrom any portion of the above-described strip of land lying within Lot E of the Partition of a portion of Lot 70 of Rancho Mission of San Diego.
