

RESOLUTION NUMBER R- 269180

ADOPTED ON SEP 8 1987

WHEREAS, the Public Relations Division of the San Diego Police Department has developed a new approach to Police/Community relations in the form of its bi-weekly talk show, entitled "Behind the Badge"; and

WHEREAS, "Behind the Badge" is a direct response to certain misperceptions that have developed in the community with regard to the Police Department and is designed to improve the public's understanding of law enforcement by increasing their knowledge on a variety of police related topics; and

WHEREAS, "Behind the Badge" is a call-in show, giving listeners the opportunity to ask questions regarding police procedures, policies, or law enforcement in general and where future shows will focus on such timely and important issues such as juvenile gangs, street narcotics, and police/community relations; and

WHEREAS, radio station KVSD-AM 1000 was the first, and currently, the only radio station in the country to venture into this previously untried area; and

WHEREAS, its gamble in this public interest endeavor is producing very good results as the program has received a tremendous amount of local support and is receiving recognition in national publications; NOW, THEREFORE,
